# PURPOSE/BACKGROUND

Pandemic Electronic Benefit Transfer (P-EBT), or Pandemic EBT, is a United States Department of Agriculture (USDA) program developed in response to the COVID-19 pandemic. The program provides food benefits to eligible families to replace meals that students would have received, if not for disruptions to in-person instruction or school facility closure.

Pandemic EBT benefits are currently being issued for school year 2020–21 (SY20–21). The American Rescue Plan Act extends P-EBT through summer 2021. Washington has submitted a plan to USDA to administer the P-EBT summer extension. All schools, including schools that did not participate in P-EBT during SY20–21 due to on-campus instruction, must upload student eligibility for students to receive benefits during the summer months.

This upload must be completed by June 14, 2021.

### **ADMINISTRATION**

The Department of Social and Health Services (DSHS), in partnership with the Office of Superintendent of Public Instruction (OSPI), is administering the P-EBT program in Washington State. Collaboration between these state agencies, local schools, and districts will ensure that Washington students receive this important benefit.

### SY20–21 P-EBT SUMMER EXTENSION—ELIGIBILITY

For purposes of the P-EBT Summer Extension, all Washington schools are considered "closed" during the summer months. All schools must upload student eligibility for students to receive these benefits during summer 2021. This upload must be completed by June 14, 2021.

#### The SY20-21 P-EBT Summer Extension is anticipated to be available to students who:

- Qualify for free or reduced-price meals in SY20–21. This includes:
  - o 20–21 Directly Certified Students through Direct Certification system
  - o 20–21 Directly Certified Students through other sources
  - o 20–21 Eligible students via new free and reduced-price meal applications
  - o 19–20 Eligible students who are not captured in the categories above
- And are enrolled (as of June 2021) in a school that normally participates in the National School Lunch Program (NSLP). This includes students that graduate in SY20–21.

All students in schools that participate in the Community Eligibility Program (CEP), or Provision 2 for both the NSLP and the School Breakfast Program (SBP), would also be eligible for benefits.

## LOCAL EDUCATION AGENCY ROLE

For students to receive P-EBT Summer extension benefits, Local Education Agencies (LEAs) must participate by uploading student eligibility information. Information provided by LEAs will be used to identify eligible students. A statewide benefit level will be used for all student benefits.

Instructions on how to upload the information are being provided to School Nutrition Departments. **This upload must be completed by June 14, 2021.**

### DATA SHARING

Data will be uploaded into a secure data portal hosted by Accenture, a DSHS contracted vendor. Section 1101(e) of the Families First Coronavirus Response Act (FFCRA, P.L. 116–127) states: "Notwithstanding any other provision of law, the Secretary of Agriculture may authorize State educational agencies and school food authorities administering a school lunch program under the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.) to release to appropriate officials administering the supplemental nutrition assistance program such information as may be necessary to carry out this section."

Data compilation and upload must be completed by school staff that have the authority to access Meal Eligibility student information.

### ASSURANCE STATEMENT

Department of Justice Enforcement Guidelines (28 CFR Parts 35, 42 and 50.3); ix. Food and Nutrition Service (FNS) directives and guidelines to the effect that, no person shall, on the grounds of race, color, national origin, sex, age, or disability, be excluded from participation in, be denied the benefits of, or otherwise be subject to discrimination under any program or activity for which the Program applicant receives Federal financial assistance from USDA; and hereby gives assurance that it will immediately take measures necessary to effectuate this Agreement. x.
