Free/Reduced Meals Information

Tahoma School District participates in the National School Lunch Program (NSLP) and the School Breakfast Program (SBP).

- Students may qualify for meal benefits based on approved applications for free and reduced-priced meals.
- The forms are available at the schools, the District's Central Services Center, the Food Service office, and online https://www.tahomasd.us/departments/nutrition_services/free_reduced-priced_meal_information
- The District mass emails the application forms to all Tahoma families before the start of the school year.
- Direct Certification: Homeless, migrant and foster students are categorically eligible for free meal benefits.

All meal benefits from the previous school year expire on October 13, 2022.

- If you want to renew your child's status, please submit a new application for SY2022-23 by October 13, 2022.
- If you do not fill out a new application and apply for meal benefits by October 13, 2022, your child's status will revert to paid until a new application is approved.
- Applications for meal benefits may be submitted at any time during the school year.
- Eligibility for school meals is used to determine eligibility for **P-EBT benefits.** Students are not eligible for P-EBT benefits unless the District has approved their application for free or reduced-price meals in SY2022-23.
- Eligibility for school meals is used to determine eligibility for fee waivers for college applications, admission tests and athletic programs. To be eligible for decreased fees or fee waivers, please allow your eligibility status to be shared with other school programs and submit the Consent-To-Share form.

Parents/Guardians are encouraged to submit a new application at the start of each school year.

- Starting on Monday, August 1, 2022 paper applications for meal benefits are available at the Tahoma Central Services Center, 25720 Maple Valley Black Diamond Rd. SE, Maple Valley, WA 98038.
- Starting on Monday, August 1, 2022, applications may be submitted online thru Skyward Family Access .
- Returning the application in a timely manner will ensure that children do not lose meal benefits and other benefits to which they are entitled. **Please complete ONE (1) application per family.**
- Please complete ONE (1) application per family.
- Per USDA regulations, all applications must be processed within 10 school days of receipt. Applications are typically processed within 48 hours. Parents/Guardians will be notified by mail when the application has been processed.
- All information on the application is confidential.

Parents/Guardians are responsible for paying for all school meals served to their child(ren) including meals served prior to qualifying for free or reduced-price meals.

- Every student has a cafeteria account.
- All cafeteria account balances will carry over to the next school year. If the student moves to a new building, the balance will transfer. We encourage parents to check their child's account balance before school starts.
- If your child's account balance is negative, please make a payment to pay down or pay off the negative balance.
- Breakfast and lunch will be served at no cost to those children who qualify for free and reduced-price meals in grades K-12. All other students will be charged the rates shown below.
